In accordance with the decision of the UEG Executive Committee, the 2017 European Championships for Seniors and Juniors in Acrobatic Gymnastics will be held in Rzeszów (POL). We are pleased to give you the following information:

VENUE AND DATES

Rzeszów (Poland), from October 16th to 23rd, 2017

Arrival: October 16th, 2017

Departure: October 23rd, 2017

COMPETITIONS, October 19th to 22nd, 2017

Qualifications for individual finals [Balance and Dynamic] and the All Round Final, for senior and junior category, are held in the following five Categories:

- Mixed Pairs
- Women's Pairs
- Men's Pairs
- Women's Group (3 athletes)
- Men's Group (4 athletes)

COMPETITION FORMAT

See current FIG Technical Regulations and UEG Technical Regulations [for individual competitions Balance and Dynamic]. Difficulty for juniors will be restricted in accordance with the rules for FIG Acrobatic Gymnastics World Age Group Competition [WAGC].

AGE

Seniors: from 15 years; born in 2002 or before

Juniors: between 13 and 19 years; born between 1998 and 2004.

Gymnasts have the right to participate if they reach the determined age during the year of the competition.

JUDGES

Each participating federation may have two category 1, 2 or 3 judges for Seniors and two judges from any category for Juniors (but with no more than 1 cat. 4 judge for Juniors), excluding any appointed difficulty judge or chair of judges.

In the draw, priority may be given to the judges of a higher category.

Federations with international brevet judges are obliged to present a minimum of one judge.

All judges will be given the opportunity to officiate in at least one event. The selection of judges (draw) is made by the TC-ACRO/UEG. The judges must be eligible to judge in the respective function. The Chairs of Judges Panel and the D1 judges are appointed by the TC-ACRO/UEG. All judges must participate in the judges' instruction meeting. The costs for judges will be charged to the respective federations.

DEFINITIVE REGISTRATIONS

Must be returned to the UEG Secretariat in Lausanne **by July 19th, 2017 at the latest.**

NOMINATIVE REGISTRATIONS

Must be returned to the UEG Secretariat in Lausanne **by September 21st, 2017 at the latest.**

SIZE OF DELEGATION

All Federations may send two units per category to the championships; only one unit from each category [highest scoring] will be allowed to proceed to a final [individual or all round].

PUBLICITY ON THE ATTIRE OF THE GYMNASTS

Federations wishing to display advertising motifs on attires used in competition by gymnasts and/or coaches must notify the Secretariat of the UEG by completing the form "Publicity on competition attire". The form must be returned to the UEG Secretariat **by September 21st, 2017.**

WORK PLAN

The work plan will be prepared after receipt of the definitive entries and the drawing of lots. It will be sent, including the draw of lots, to the participating federations according to the deadline stipulated in the FIG and UEG Technical Regulations in force.

FIG LICENCE

All gymnasts must have a FIG licence which has to be presented upon accreditation.
