ACCREDITATION	<p>The accreditation will take place at the PalaPrometeo Estra upon arrival to Ancona. The accreditations will only be handed out to the Head of Delegation. All delegations must deliver its flag, the insurance declaration in English writing, passports of all members and FIG Licenses.</p> <hr/> <p>In order to organise the accreditation, each National Federation has to send the Definitive Registration (deadline 16th June 2017) and Nominative Registration (deadline 16th August 2017) directly to the LOC at the email registration.ag1@nesea.it in order to confirm the number of participants. Starting from the 16th of June 2017, all the Nominative Registration data will be checked and uploaded on NESEA SportCARE Digital Platform (http://europeanag1.sportcare.tech), technical partner of the event, and each Federation, with its login credentials, will be able to upload anthems, photos and musics (.mp3 format) for each individual, mixed pair, trio and group performance. INSURANCE	<p>The Host Federation, the LOC and the FIG will not be held responsible for any liabilities in case of accidents, illness, repatriation and the like.</p> <p>The FIG Technical Regulations foresee that all participating Federations are responsible for making their own arrangements to have the necessary valid insurance coverage against illness, accidents and for repatriation for all the members of their Delegation.</p> <p>The LOC will verify the insurance upon arrival of the delegation members (e.g. cover note or photocopy of the valid policy). Delegation members with insufficient insurance cover must inform the LOC in advance.</p> <p>The LOC will subsequently offer insurance at the Federations own charge as follows: € 35, 00 per person/day.</p>
