<b>AGE LIMITS</b>	AG1: 12-14 Years / AG2-Juniors 15-17 years / Seniors 18 + years <b>All gymnasts must have a licence valid until the end of the event</b>
<b>JUDGES AND JURIES</b>	The number of Juries (judges’ panels) may be decided by the Organizing Member Federation depending on the number of participating competitors and judges. <b>All judges must have a current valid FIG brevet.</b> The Juries are set up by a draw and directed by the Technical Delegate from

	<p>the judges present at the event. Priority will be given to the judges of the highest category. If, on the day of the competition, there are no sufficient numbers of judges in the requested categories, the Technical Delegate may take whatever action needed to secure the running of the event. Each participating federation must provide minimum one judge Cat. 1, 2, 3 or 4 with current valid brevet. Failure to do so, will result in a fine of CHF 2'000.- to be paid to the LOC until the Definitive Registration date (22-01-2020).</p>

At the time of the Definitive entry (2 months prior to the event) 100% of the entry fee must be paid to the LOC. All the entry fees are not refundable.</p>						
<b>ACCREDITATION</b>	<p>In addition, the LOC will distribute information regarding the gymnasts' safeguarding plan.</p> <p>The accreditation will take place at the Sports Hall "Os Marialvas" upon arrival to Cantanhede. The accreditations will only be handed out to the Head of Delegation.</p> <p>All delegations must deliver 2 memory sticks with the musics of all routines, national anthem and flag, <b>SPORTIVE INSURANCE declaration</b>, passports of all members and FIG Licenses.</p>						
<b>EVENT FORMAT</b>	<p>The Aerobic Gymnastics International Open Competition will have Qualifications and Finals in all categories. Aerobic Gymnastics Categories: IW, IM, MP, TR, GR &amp; GRAD. <b>VISA</b>	<p>Please verify immediately with your travel agent or the <b>Portugal</b> Embassy or Consulate in your country if a visa is required for your travel to <b>Portugal</b>. The LOC will be happy to assist each Delegation member with an official invitation letter, provided that the request is made before <b>20, January, 2020</b> to the LOC.</p> <p>The request must include the function, full name, gender, date of birth, citizenship and passport number, passport expiry date, the arrival and departure dates of the Delegation Member as well as the city the visa</p>						

	application support letter must be sent to.
<b>INSURANCE</b>	<p>The Host Federation, the LOC and the FIG will not be held responsible for any liabilities in case of accidents, illness, repatriation and the like. The FIG Technical Regulations foresee that all participating Federations are responsible for making their own arrangements to have the necessary valid insurance coverage against illness, accidents and for repatriation for all the members of their Delegation.</p> <p>The LOC will verify the insurance upon arrival of the delegation members (e.g. cover note or photocopy of the valid policy). Delegation members with insufficient insurance cover must inform the LOC in advance.</p> <p>The LOC will subsequently offer insurance at the Federations own charge as follows: <b>40€ (forty euros)</b> per person/day.</p>
