ENTRY FEES	The invited participating federations must pay for all entry fees. At the time of the Definitive entry (2 months prior to the event) 100% of the entry fee must be paid to the LOC – not later than 22 February 2020. All the entry fees are not refundable.		
	For delegations not having booked their accommodation through the LOC, the Category Entry Fees are: IW/IM 120€, MP: 240€, TRIO: 350€, GROUP: 560€, AEROBIC DANCE 700€		
	The accreditation will take place at the Polivalenta Sports Hall upon arrival to Bucharest. The accreditations will only be handed out to the Head of Delegation.		
ACREDITATION	In addition, the LOC will distribute information regarding the gymnasts' safeguarding plan.		
	All delegations must deliver 2 memory sticks with the musics of all routines. They should also bring: the national anthem and flag, SPORTIVE INSURANCE declaration , passports of all members and FIG Licenses.		
	The 1 st Bucharest Open Cup – Aerobic Gymnastics will have Qualifications and Finals in all categories. Aerobic Gymnastics Categories: IW, IM, MP, TR, GR & AD.

EVENT FORMAT	The number of participants in IW and IM is limited to 6 units per NF except Organizing Federation		
	There is no limitation of participants for MP, TR, GR and AD (AG2 and SEN) by nation / age group.		
	There will be qualifications only for the categories and age groups with more than 9 participants.

	The drawing of lots will take place at the Romanian Gymnastics Federation two weeks after the closing date of the nominative registration. After publication of the draw to all participating federations there will be an opportunity to modify the position of the gymnasts' starting order within 3 days by using the official document.
PROVISIONAL SCHEDULE	 Day 1, 22nd April: Arrival of Delegations Day 2, 23rd April: Training Sessions, Orientation meeting, judges meeting (IOC & Youth Competition) Day 3, 24th April: Qualifications Day 4, 25th April: Qualifications Day 5, 26th April: Finals Day 6, 27th April: Departure of Delegations (All day) There might be some changes in the Provisional Schedule depending on the total number of entries. The detailed Program will be prepared and distributed to all participating Federations with the Work Plan, not later than 9 April 2020.
MEDICAL SERVICES	The Local Organizing Committee will provide first aid medical services. A physiotherapist will be present during the competitions as well members of the Romanian specialized in first aid.
VISA	Please verify immediately with your travel agent or the Romania Embassy or Consulate in your country if a visa is required for your travel to Romania . The Organizing Committee will be happy to assist each Delegation member with an official invitation letter, provided that the request is made before 22nd February 2020 to the LOC. The request must include the function, full name, gender, date of birth, citizenship and passport number, passport expiry date, the arrival and departure dates of the Delegation Member as well as the city consulate where the visa application support letter must be sent to.
INSURANCE	The Host Federation, the Local Organizing Committee and the FIG will not be held responsible for any liabilities in case of accidents, illness, repatriation and the like. The FIG Technical Regulations foresee that all participating Federations are responsible for making their own arrangements to have the necessary valid insurance coverage in case of illness, accidents and for repatriation for all the members of their Delegation. The LOC will verify the insurance upon arrival of the delegation members
	(e.g. cover note or photocopy of the valid policy). Delegation members with insufficient insurance cover must inform the LOC in advance. The LOC will subsequently offer insurance at the Federations own charge as follows: 20€ (twenty euros) per person/day.
INTERNATIONAL TRANSPORTATION	The invited participating Federations must pay for the travel cost of their delegation members. The Travel Schedule Form must be returned to the LOC by 25th March 2020 . If persons from one delegation/ Federation are arriving and departing with different flight, please fill in separate travel forms for each group of persons and indicate on travel form the exact number of persons.

LOCAL TRANSPORTATION	 Arrival and departure - Bucharest. The LOC may provide transportation to all delegation members who have booked their accommodation through the LOC, from Otopeni Henry Coanda Airport, Bucharest railway station to their hotel and back on the official arrival (22nd April 2020) and official departure days (27th April 2020). This transportation is free of charge. For those delegations or members of delegations that do not arrive or depart on the official days, the LOC may arrange additional transportation, upon request. The cost of which depends on the number of people, the date and time. Please send your request to the LOC not later than 25th March 2020 in order to be able to arrange transportation and inform you about the price. The LOC will ensure the local transportation between the Hotel and the competition hall for the participants who booked the accommodation through the LOC
