Dear President,

We are happy to confirm your qualification as per the enclosed list of qualified countries/athletes (appendix 1) and to give you the directives / invitation for The World Games 2022 which will be held in Birmingham, AL (USA). We kindly ask you to carefully study this document and pay special attention to the deadlines. Thank you for your cooperation.

1. General Information about The World Games

The World Games 2022 will take place from 10th July to 17th July 2022 in Birmingham, AL (USA). The World Games take place every 4 years in the year following the summer Olympic Games. They are governed by the International World Games Association (IWGA), recognised by the International Olympic Committee (IOC) who support The World Games.

Similar to the Olympic Games, the participation is limited by a quota (number of athletes per discipline) and therefore, qualifying events and criteria are necessary.

The FIG quotas confirmed by the IWGA for The World Games 2022, have slightly changed from the previous edition. The details are as follows:

- All 6 units per category, maximum one (1) per NF.
- The top 4 units per category qualify for the Finals.

9. Entry procedures / Entry Forms / Entry Fees

Definitive Entry

With the revision of the Qualifiers (please see attached), please fill in the enclosed Definitive Entry Form (appendix 2) and return it to the FIG – Rui Vinagre: rvinagre@fig-gymnastics.org, as soon as possible, but no later than **March 14, 2022** (23:59 Swiss time).

National Federations with reserve gymnasts must also send the form with the relevant information.

For Parkour (PK), the qualifiers will be informed in due time, and the registration process will start at that time. New information will be provided whenever available.

In case the National Federation already sent the form to FIG, we kindly ask you to re-send the form attached.



Late entries will not be accepted and will result in the FIG automatically inviting the 1st reserve qualified NF.

Entry fees (based on the Definitive Entry):

- RG/ACRO/AER/TUM/DMT/PK: CHF 150 per competitor

The FIG will issue an invoice for the entry fees after the Definitive Entry. These fees must be paid within 30 days after the invoice's date.

Nominative Registrations – “Long List”:

After receiving the Definitive Entry Form (appendix 2) mentioned above, FIG will send to the participating federations a link allowing them to register in the Nominative Long List of participants (athletes and officials).

The deadline to complete the Nominative Long List is **March 18, 2022**.

10. Accommodation and Payments

The BOC will pay for accommodation in twin room and catering for all **qualified athletes**, as follows:

- PK - 8th to 12th July = 4 nights (+1 night for athletes who fly from outside of USA)
- RG - 9th to 14th July = 5 nights (+1 night for athletes who fly from outside of USA)
- AER - 10th to 14th July = 4 nights (+1 night for athletes who fly from outside of USA)
- TUM, DMT and ACRO – 13th to 18th July = 5 nights (+1 night for athletes who fly from outside of USA)

Accommodation for all other members of the delegation is at the charge of your federation. The costs are as follows and include accommodation in single and/or twin room, full board, transportation, airport pick up and BOC administration fee and city taxes:

- Single room: USD 200 per person / per night
- Twin room: USD 150 per person / per night

The number of single rooms is limited; therefore BOC and FIG cannot guarantee this type of accommodation for all requests.

Accommodation Reservation Form:

After receiving the Definitive Entry Form (appendix 2) mentioned above, FIG will send to the participating federations a link allowing them to register in the Accommodation Registration Form. The deadline to complete the Accommodation Registration Form. is **March 18, 2022**.

The Accommodation costs must be paid within 30 days after the invoice's date. The participating federation is responsible for covering all bank fees in connection with the bank transfers.

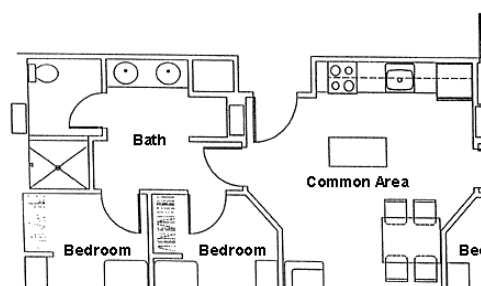
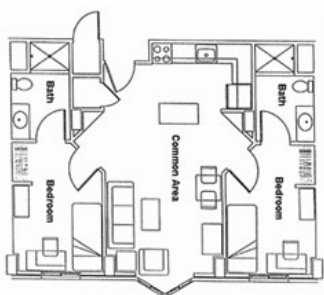
Bank details (Beneficiary name, Bank name and address, Account number, IBAN and BIC) to be used, will be stated on the FIG invoice.

Booking and payment of additional nights (earlier arrival or later departure) are at the responsibility of your relevant National Federation.

Accommodation Type

All participants (athletes and officials) will stay in the Athlete Village at UAB – University of Alabama.

The types of accommodation are as follow:



11. Transport / Flights

All travel costs to/from Birmingham, AL (USA) are at the charge of the respective National Federation.

BOC provides transportation service from 7th to 18th July 2022.

Airport Shuttle for pick up and drop off service for the delegation members will be provided to and from Birmingham-Shuttlesworth International Airport (code BHM) based on the flight details given during the accreditation application process.

Local transportation (shuttle buses) will be provided between the accommodations and the venues.

FIG will send to all participating NFs an "excel form" as soon as we receive the detailed information from BOC.

12. Accreditation Cards

Accreditation will only be given by BOC through the FIG. The FIG will, based on the information received at the time of the Definitive and Nominative Entries, request accreditation for all delegation members. Access to the various zones will be given as agreed between the IWGA, the FIG and BOC.

13. Licences

No athletes will be accepted without a valid FIG License at the deadline of the Nominative Registration (Final list of athletes).

14. Judges

Every delegation is obliged to send one judge for each discipline in which it participates (please refer to # 8 of this document). Judges must have a valid FIG brevet of the respective discipline for the Cycle 2022 – 2024. Priority must be given to the judges with category 1 and 2. Federations who don't have a judge category 1 or 2 may send a judge category 3.

Failure to enter the minimum number of judges as requested above by **March 18, 2022** will result in the FIG charging the respective member federation with Swiss Francs (CHF) 2'000.-. This amount will be used to cover the costs of an invited neutral judge. The same amount will be charged, should an announced judge not be present in due time at The World Games.

15. Music rights / Music forms

The rules of the IWGA and the FIG require that all participating federations must clear the music rights. For all federations who have qualified competitors performing with music, it is therefore compulsory to make sure that the music used at The World Games is fully cleared with regard to commercial rights for broadcasting images and sound.

By signing the Nominative Entry, you accept the above and confirm that you have cleared the music rights.

The Music Form will be sent to all concerned NFs in due time.

16. COVID and Visa

The Birmingham Organizing Committee (BOC) continues to monitor the developing of the COVID-19 pandemic situation worldwide to make plans accordingly. It is imperative that federations stay up to date on the latest news while the BOC provides further direction at the Competition Managers and NOC Meetings later this year.

Obtaining a visa will be pertinent for many of the attendees of The World Games 2022. The key is starting the process well in advance of the travel date. Below are some steps and information pertaining to a US Visa to attend the The World Games 2022.

- Register through the The World Games 2022 Registration Portal. Letters of Invitation will be available to those approved registrants. They will be sent to the email on file, upon registration.
- Determine if you need a Visa to enter the United States. There are currently 38 countries that participate in the Visa Waiver Program. These countries are listed in the State Department Website found in the following link: [Visa Waiver Program \(state.gov\)](#)
- If your country is not part of the Visa Waiver Program, contact the nearest US Embassy and Consulate regarding obtaining visas. A listing of US Embassies and Consulates can be found at the following link: [Official list of Embassies from the U.S. Department of State \(us embassy.gov\)](#). In addition, there are companies and agencies that will assist with obtaining visas for a fee. The type of visa that will be obtained for the majority of the attendees will be type B1 per the following site [Directory of Visa Categories \(state.gov\)](#). Best practices are to start the process as much in advance of the travel date as possible. Some National Governing Bodies have been known to obtain visas for those with a chance of qualification to start the process well in advance.

The Host Federation, the LOC and the FIG will not be held responsible for any liabilities in case of accidents, illness (including COVID-19), repatriation and the like.

According to the IWGA rules and regulations **each member of delegation** has to show a proof of their health insurance cover at the Accreditation Center in order to obtain an accreditation card with full rights of participation. Without that proof of health insurance coverage, no accreditation will be delivered.

Basic insurance (sickness, accident and repatriation) in your country of residence is compulsory in order to be able to benefit from coverage by FIG IMSSA subsidiary insurance. Please also refer to <https://www.gymnastics.sport/site/pages/medical-insurance.php> for additional information regarding the FIG IMSSA insurance for Athletes and Judges.

BOC is responsible for executing the practices of the WADA Anti-Doping Rules. Doping controls will be made during The World Games as per WADA and FIG regulations.

For The World Games, the FIG Advertising and Publicity Rules apply, with the following exception: ALL advertising and publicity – size as per FIG Rules - must be approved by BOC. BOC will in principle allow all sponsors (products), which are not in conflict with a main sponsor of BOC. Federations who wish to place publicity on competition attire (incl. bags, track suits, t-shirts etc.) must make a **written request to FIG as soon as possible, but no later than May 4th , 2022**. This request must include the name of the sponsor and the product, the placement and size and which competitors will wear it. FIG will then seek approval from the BOC and inform the Federation concerned about the decision.

Federations which have not presented a request until April 30th, 2022, will not be allowed any publicity and advertisement on the competition attire.

20. Drawing of Lots

The drawing of lots for the starting order will take place in Lausanne – FIG Headquarters. Information about the date and time will follow in due time.

21. Work Plan

The Work Plan will be distributed at the latest, 6 weeks before the start of TWG 2022.
