PARTICIPATION	The International Open Competition consists of qualifications and finals. There will be qualifications only for the categories and age groups with more than 9 participants. In case of a tie in any place, the tie-breaking rules are as set by FIG. Participation in the finals:
	The top eight units per category and age group will qualify for the Finals. In case of a tie at any place, the tie-breaking rules are the FIG World Championships Rules.
	The LOC may cancel the competition in the respective category if at the time of
	the definitive entry, there are less than 3 countries registered in a category.
	In case of such a cancelation, the LOC must reimburse, in full, the entry fee and payments made for accommodation.
	Should flights have to be cancelled due to the above, the risk is at the charge
	of the participating member Federations.
SIZE OF THE	The number of participants by nation, category and age group is not limited.
DELEGATION AND FIG LICENSE	All AG1 (12-14 Years), Juniors / AG2 (15-17 years) and Seniors gymnasts in good standing with the correct age and holding a valid FIG license until
	the end of the event, may participate.
	The LOC will be responsible for checking the validity of all gymnasts Licenses.
AGE LIMITS	AG1: 12-14 Years / AG2-Juniors 15-17 years / Seniors 18 + years
CATEGORIES	IW / IM / Mix Pair / Trio / Group (all age categories) / Aerodance (AG2 & SNR)
JUDGES & JURIES	The number of Juries (judges' panels) may be decided by the Organizing Member Federation depending on the number of participating competitors and judges.
	All judges must have a current valid FIG brevet.
	The Juries are set up by a draw and directed by the Technical Delegate from the judges present at the event. Priority will be given to the judges of the highest category. If, on the day of the competition, there are no sufficient numbers of judges in the requested categories, the Technical Delegate may take whatever action needed to secure the running of the event. Each participating federation must provide minimum one judge Cat. 1, 2, 3 or 4 with current valid brevet. Failure to do so, will result in a fine of CHF 2'000 to be paid to the LOC until the Definitive Registration date (20-01-2021).
REGISTRATION DEADLINES	Provisional, Definitive and Nominative Registrations must be completed by sending the composition of the delegation to the LOC. Late entries will be considered as invalid and will be refused.

	Registrations and payments made after the gymnasts' drawing of lots will not be accepted and the Delegation members concerned will not be authorized to participate.
DRAWING OF LOTS	The drawing of lots will take place at the Gymnastics Federation of Portugal Federation two weeks after the closing date of the nominative registration. After publication of the draw to all participating federations there will be an opportunity to modify the position of the gymnasts' starting order within 3 days by using the official document.
ENTRY FEES	The costs for the entry fees are:

LOCAL TRANSPORTATION	The Organizers will arrange at a determined fee, the transport service from the LISBON International airport and OPORTO International airport to the accommodation place in Cantanhede and to the competition hall

The Organizing Committee will be happy to assist each Delegation member with an official invitation letter, provided that the request is made before 20 , January , 2021 to the LOC. The request must include the function, full name, gender, date of birth, citizenship and passport number, passport expiry date, the arrival and departure dates of the Delegation Member as well as the city the visa
	application support letter must be sent to.
INSURANCE	The Host Federation, the Organizing Committee and the FIG will not be held responsible for any liabilities in case of accidents, illness, repatriation and the like.
	The FIG Technical Regulations foresee that all participating Federations are responsible for making their own arrangements to have the necessary valid insurance coverage against illness, accidents and for repatriation for all the members of their Delegation.
	The LOC will verify the insurance upon arrival of the delegation members (e.g. cover note or photocopy of the valid policy). Delegation members with insufficient insurance cover must inform the LOC in advance. The LOC will subsequently offer insurance at the Federations own charge as follows: 40 €
