**European Gymnastics is pleased to herein provide you with the Directives for the 35<sup>th</sup> European Women's Artistic Gymnastics Championships, to be held in Rimini (ITA) from 2 – 5 May 2024.**

These European Championships will be organised following the FIG & European Gymnastics Statutes and Technical Regulations (TR), FIG Code of Points and relevant newsletters and help desk, FIG General Judges Rules, FIG Specific Judges Rules, FIG Anti-Doping Rules, European Gymnastics Medical Guidelines, the Medical Organisation of FIG Competitions and Events, the FIG Framework for Safeguarding Athletes and other Participants from Harassment and abuse in Sport during Events, the FIG License Rules, European Gymnastics Media Rules, FIG Apparatus Norms, FIG Advertising and Publicity Rules, FIG Rules for Sanctioning (approval) of International Events and European Gymnastics Accreditation Directives, FIG Code of Ethics, FIG Code of Conduct, FIG Code of Discipline, Rules for Award Ceremonies as well as all other Rules and Guidelines valid starting 01 January 2024 onwards, any possible amendments by the date of these European Championships, and any complements decided in the meantime.

All participating Federations commit to abide by the Statutes and all European Gymnastics & FIG Rules and Regulations. National Federations not respecting them will not be allowed to compete.

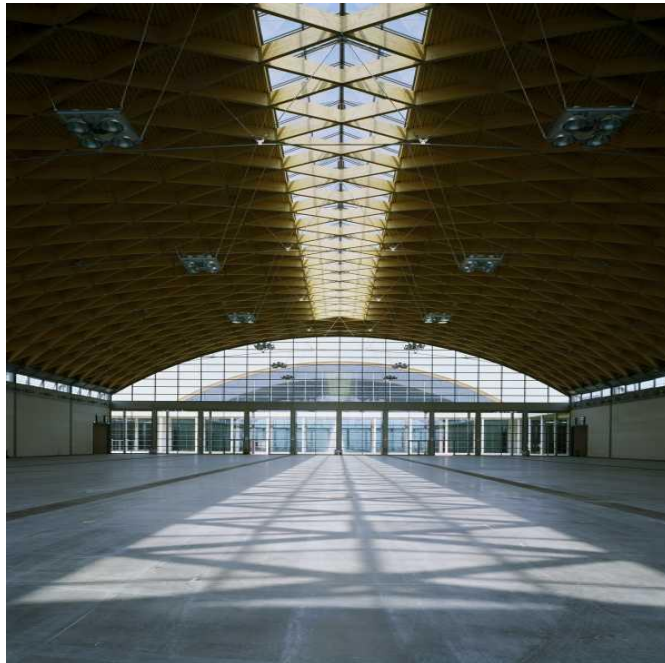

## 5. PARTICIPATION RIGHT AND ACCREDITATIONS

---

Senior and Junior Gymnasts holding a valid FIG licence until the end of the competitions, and with the correct age from European Gymnastics and FIG affiliated Federations in good standings, may take part in these European Championships. An individual is entitled to only one accreditation card. If an individual has several valid “accreditable” functions, the highest function is normally selected and the access zones of the functions are cumulated. No substitutes may directly benefit from unused accreditations. The functions of judge and gymnast cannot be combined with any other function, except for a gymnast who can also act as Head of Delegation.

### Maximum Delegation Size

---

The maximum size of each delegation, as per European Gymnastics Technical Regulations, is as follows:  
All federations are entitled to participate with either a team composed of 3 to 5 gymnasts, or individual gymnasts.

Additional accreditations are at the charge of the delegations. The cost of these accreditations are as follows:

The cost for additional accreditations must be paid directly to the LOC. An additional invoice will be sent to the concerned NF, including the bank details of the LOC.

### Accreditation Application Process

---

Each National Federation (NF) is kindly asked to enter the personal details and to upload photos of all delegation members in the following online accreditation tool of the LOC:

**<https://acc.gymresult.it/>**

The online accreditation system will be open from **1 February 2024** and will be closed on **4 April 2024**.

All details on how to access the LOC online accreditation portal and description of the application process will be provided to each NF by the LOC after the definitive registration deadline.

This will involve entering personal information (name, date of birth etc.), assigning the correct Job Title (e.g. Athlete, Coach, Doctor) and uploading a photograph which meets the requirements below.

The photograph must follow the same requirements as for a passport:

- It must be in **colour**, should be a recent and an accurate likeness of the applicant and must not have been altered in any way
- It should be a **front view of the applicant's face, head and shoulders (facing forward and looking straight at the camera)**; hats, hair bands or dark glasses must not be worn.
- It should show the full head, without any head covering, unless worn for religious beliefs or medical reasons
- With a neutral expression and with the mouth closed
- With eyes open and clearly visible (no sunglasses or tinted glasses and no hair across the eyes)
- No objects, other people or shadows in the photo
- The **background must be plain and light colour, preferably white** but light blue and light grey will be accepted (NO black, dark blue, red etc.)
- Be clear and in sharp focus
- Be taken within the last 6 months

Details should be entered for all participants **until no later than 4 April 2024**. This includes applications for accreditation of additional coaches, paramedical staff and guests for whom the NF will assume the participation costs, as described above.

Please consider: If photos will have to be taken at the accreditation desk (because they were not sent within the deadline/in the correct format) **EUR 50.-** will be charged for each photo.

All data submitted by NFs via the Smart Scoring platform are subject to the approval of European Gymnastics. The European Gymnastics Accreditation Rules will be strictly applied, notably as far as the number of accreditations per federation is concerned. No further accreditations may be issued. Any additional person is considered a spectator and must buy entry tickets.

Accreditation cards will not be delivered unless all financial and insurance obligations have been successfully completed.

In addition, each NF **must also** register on the **European Gymnastics GymData Online registration system** by the stated entry deadlines for Definitive & Nominative entry (see Point 7).

## Media Accreditations

---

International and local media representatives as well as federations' communication staff who are interested in covering the event can register online through the European Gymnastics website: [Media | European Gymnastics](#).

Deadline: **17 April 2024**.

The European Gymnastics Accreditation Rules and Media Rules have to be strictly respected.

## 6. AGE LIMIT OF GYMNASTS

---

The age of WAG Juniors in 2024 is age 14 – 15 years old (born 2010 - 2009).



The age of WAG Seniors in 2024 is minimum 16 years old (born 2008) or older.

Gymnasts who have participated in a Senior World Championships, a Senior Continental Championships, a World Cup / World Challenge Cup, and Multi-Sport Games, may not participate afterwards in Junior competitions.

**All gymnasts must have a valid FIG licence until the end of the event.**

## 7. REGISTRATION AND ENTRY FEES

---

Registrations can only be made by European Gymnastics and FIG affiliated federations in good standing, via the **European Gymnastics GymData Online registration system** from SmartScoring (<http://registry.gymdata.online/>) and by using the National Gymnastics Federations' login and password.

### Definitive Registration

---

The definitive registrations must be completed by entering the composition of the delegation **until 1<sup>st</sup> February 2024 (23:59 Swiss time) at the very latest.**

### Nominative Registration

---

The nominative registrations must be completed by entering the composition of the delegation **until 4<sup>th</sup> April 2024 (23:59 Swiss time) at the very latest.**

Reminder: Together with the nominative registration, delegations must complete their accreditation application via the LOC online system <https://acc.gymresult.it/>

**No late registrations will be accepted after the Drawing of Lots** (i.e. the gymnasts will not be allowed to compete), however, a NF who has registered a Team is authorized to add gymnasts to the number declared at the Definitive Registration, up to the maximum quota allowed (Ref. FIG Technical Regulations - Section 2 - Art. 6 - Registration Changes).

All bank fees in connection with the bank transfer must be covered by the respective Federation. Please state the name of the Federation and the payment purpose on the transfer (i.e. 'ITA\_2024 WAG ECH Registration Fees').

**The payment must be made in EUR only.**

Federations which have not fulfilled their financial obligations towards European Gymnastics or FIG (e.g. annual membership fees, unpaid invoices etc.) and the LOC (e.g. hotel, meals, etc.) will not be allowed to participate in these European Championships.

In case of non-participation or partial participation the fee will not be reimbursed.

## Sanctions

---

The sanctions are as follows as per European Gymnastics /TR (Article 3.2.5)

## 8. LICENCES

---

**No gymnasts will be accredited without a FIG licence valid** until the end of the competitions.

Licence application forms (new or renewal) must be submitted **at least one (1) month prior to the deadline for the nominative registration.**

Please consult the FIG licence rules for additional information in this respect.

## 9. JUDGING

---

Each National Federation with a Team or Individual gymnasts for the Senior **or** Junior competitions has the obligation to nominate 1 judge. Each National Federation with Teams or Individual gymnasts for the Senior **and** Junior competitions must nominate 2 judges and must declare on entry, which Judge is designated to the Senior competition & which Judge is designated to the Junior competition.

If a Federation does not enter a judge or comes with an insufficient number of judges, European Gymnastics, in line with the Technical Regulations, will request payment in the sum of EUR €2,000.00 per missing judge.

**All judges must have a current valid FIG brevet and category,** for their function **according to FIG Judges rules at the time of the event.**

Whilst the presence of E-Judges at the Official Podium Training is not mandatory, the WTC would strongly encourage all NF to ensure their E-Judges are present at Podium Training.

## 10. DRAWING OF LOTS

---

The gymnasts' drawing of lots will take place after the deadline of the Nominative Registration, on **11<sup>th</sup> April 2024** at the Head Office of European Gymnastics.

The composition of subdivisions is decided by drawing of lots among the teams and individual gymnasts.

**For Juniors,** the draw will be **open**, and will start with the final Subdivision and work its way back to Subdivision 1. As Federations are drawn, they will be placed horizontally across the apparatus working in Olympic order. The draw will continue until all Federations have been drawn.

**For Seniors,** the draw will start with the **4 highest ranked Teams from the Qualification Competition at the European Championships in Antalya 2023,** drawn in the final subdivision and placed horizontally across the apparatus working in Olympic order.

The draw will then continue with the remaining teams and individual gymnasts to complete the final Subdivision

and then work its way back to Subdivision 1. As Federations are drawn, they will be placed horizontally across the apparatus working in Olympic order. The draw will continue until all federations have been drawn.

## 11. COMPETITION FORMAT

---

According to FIG TR 2023, the 2024 European Championships is a qualifying event for the Olympic Games Paris 2024.

For details, see the FIG TR **Appendix A – Qualifications Pathway. – Criteria 7**

### Competition Format

---

#### **QUALIFYING COMPETITION**

**Seniors - Qualifying Competition including All-Around Final, plus qualification for Apparatus Finals and Team Final**

**Juniors - Qualifying Competition including All-Around and Team Final, plus qualification for the Apparatus Finals**

A Senior and Junior team consists of 3 - 5 gymnasts, of which up to 4 gymnasts compete on each apparatus. The 3 best scores on each apparatus are added together to make the team total on that apparatus. The NF nominates the team on each apparatus.

If a Federation does not have a sufficient number of gymnasts for a full team, it is possible to participate with Individual gymnasts.

A separate All-Around Final result list will be produced to include the 24 gymnasts with the highest ranking obtained. A maximum of 2 gymnasts per Federation will be taken into consideration.

The results from the Senior Qualifying Competition will determine the All-Around Senior European Artistic Gymnastic Champion 2024.

The results from the Junior Qualifying Competition will determine the Junior European Artistic Gymnastics Team Champions 2024 as well as the All-Around Junior European Artistic Gymnastic Champion 2024.

#### **SENIORS & JUNIORS - Apparatus Finals**

The 8 highest ranked gymnasts on each apparatus from the Qualifying Competition will qualify for the respective Apparatus Final. A maximum of two gymnasts per Federation will be allowed in the finals.

#### **SENIORS - Team Final**

The 8 best Teams from the Qualifying Competition will participate in the Team Final. Teams consist of 3 to 5 gymnasts. 3 gymnasts will compete on each apparatus with all 3 scores counting towards the total score for the Team on that apparatus.

#### **RESERVE GYMNASTS:**

For the Apparatus Finals, the following number of reserve gymnasts will be designated, by taking into account the respective Apparatus ranking results in the Qualification Competition:

- Three (3) gymnasts per apparatus

If called upon, a reserve works in accordance with the order of the gymnasts replaced. Reserves must be prepared to compete and must be present in the warm-up hall in case they are called upon.

The provisional training, warm-up and competition schedules will be included in the Work Plan.

## 12. EQUIPMENT

---

The Manufacturer Supplier will be Spieth. Please refer to Appendix 1 for the complete List of Apparatus which will be used, including the certified product names and article numbers.

## 13. PUBLICITY

---

FIG advertising and publicity rules must be respected.

As the Code of Points outlines deductions should the FIG rules for Advertising and Publicity on attire and equipment not be respected, each Federation may fill in the online FIG Publicity form (FIG Rules for Advertising and Publicity Appendix F for women) if deemed necessary and send it to European Gymnastics by **4<sup>th</sup> April 2024** at the very latest in order to have it approved.

While the Publicity Rule Chart is available on the FIG website under “Rules – Publicity” for additional information, you may also contact [ldavila@europeangymnastics.com](mailto:ldavila@europeangymnastics.com) for further assistance if required.

## 14. WAG MUSIC

---

The music must be submitted online via LOC digital platform <https://acc.gymresult.it/> by no later than **4 April 2024**. The sign in details to access the online platform will be sent to the participating countries after the definitive entry's deadline.

Each delegation, logging in with its credentials at LOC digital platform has to submit the Music files for each performance as well as the National Anthem.

MUSICS have to be uploaded in the following file format: .mp3

Name of file must contain:

- The name of the nation (official abbreviation of the country);
- The first and last name of the individual competitor/s
- The category
- The Junior or Senior (Example: ITA\_ AMATO\_Asa\_Senior\_.mp3)

NATIONAL ANTHEM has to be uploaded in the following file format: .mp3

Name: Official abbreviation of the country + Anthem (Example: ITA\_Anthem)

If you need help, you can write to the following e-mail address: [support@gymresult.it](mailto:support@gymresult.it)

Delegation members are requested to keep in their possession a CD and USB key of their music for their training sessions and in case of a technical problems.

Each Federation will also have to confirm that the music used does not violate any copyrights and that it can be broadcasted within sports. At the accreditation, the Heads of delegation have to hand in the Music Release form which you will receive together with the work plan.

## 15. VISA

---

Please verify immediately with your travel agent or the Italian Embassy or Consulate in your country if a visa is required for your travel to Italy. The Organising Committee will be happy to assist each Delegation member with an official invitation letter, provided that the request is made before **24 February 2024** to Mrs. Claudia Ferrauto at the following email address: [Claudia.ferrauto@federginnastica.it](mailto:Claudia.ferrauto@federginnastica.it) or Tel: +39 0687975021

The request must include the function, full name, gender, date of birth, citizenship and passport number, passport

expiry date, the arrival and departure dates of the Delegation Member as well as the city the visa application support letter must be sent to.

## 16. TRANSPORTATION

---

**European Gymnastics and the LOC strongly recommend that each Federation take a cancellation insurance for their travel.**

### International Transportation

---

The invited participating Federations must pay for the travel costs of their delegation members. The official arrival airports are:

- “Federico Fellini International Airport” in Rimini (RMI - 7,5 Km from Rimini)
- “Guglielmo Marconi International Airport” in Bologna (BLQ - 125 Km from Rimini)

You can also arrive to Rimini Railway Station by train via Adriatic Line.

All accredited persons who have booked an official Rimini 2024 package through the Rimini 2024 LOC will be provided with transfers from and to Rimini / Bologna Airport or Rimini Train Station.

**All other delegation members are NOT included in this insurance and must present a proof of insurance at the accreditation.**

Delegation members with insufficient insurance coverage will subsequently be offered with insurance at the Federations own charge as follows: **€ 15,00** per person/day.
