The only situation in which safety distance does not have to be respected is
when a coach provides assistance (catch, lead, spottiong) during an athlete's
performance. This phase must be kept as short as possible and the assisting person is obliged to wear a mask throughout.
Gymnasts do not need to wear a mask or fase covering while they are
