COVID 19	Besides the medical guidelines for the particular event, FIG also requires	
FIG GUIDELINES	all the participants to follow the standard precautions.	
	The FIG requires all participants, judges and officials to take standard precautionary measures, such as frequent hand-washing, wearing masks or face coverings at all times and keeping a physical distance of at least 1.5 metres whenever possible.	
	The only situation in which the safety distance does not have to be respected is when a coach provides assistance (catch, lead, spotting) during an athlete's performance. This phase must be kept as short as	
	possible and the assisting person is obliged to wear a mask throughout.	
	Gymnasts do not need to wear a mask or face covering while they are performing at the training venue or on the FOP and keeping a physical distance of at least 1.5 metres whenever possible.	
	All delegation must bring Negative PCR test results 48h before the time of arrival in Slovakia.	
	Please note that the regulations may vary according to the actual COVID 19 situation and may change!!!!	
INSURANCE	The Host Federation, the Organizing Committee and the FIG will not be responsible for any liabilities in case of accidents, illness, repatriation and the like.
