These World Championships will be organized following the FIG Statutes, the 2022 Technical Regulations, the 2022-2024 PK Code of Points as well as FIG Framework for Safeguarding Athletes and other Participants from Harassment and Abuse in Sport during Events, and all other Rules, Regulations and Guidelines valid, any possible amendments by the date of these WCH, and any additions decided in the interim.

All participating Federations commit to abide by the Statutes and all FIG Rules and Regulations. National Federations not respecting them will not be allowed to participate.

5. PARTICIPATION AND ACCREDITATIONS

All NFs in good standing are entitled to participate with a full quota of max. 8 men and 8 women.

The size of delegation is as follows.

Athletes can participate in both events provided that the maximum athlete quota place per event (max.4) is not exceeded.

For other delegation members, see FIG Accreditation Rules.

6. AGE LIMIT OF ATHLETES

All participants must be minimum 17 years old in the year of the event (i.e., born in 2005 or earlier).

7. REGISTRATIONS

Registrations can only be made by FIG affiliated federations in good standing, via the **FIG** on-line system (click [here](#)) and by using the National Gymnastics Federations' login (e-mail) and password.

Definitive Registration

The definitive registrations must be completed by entering the composition of the delegation by 23:59 CET (Swiss Time) on Wednesday, 20 July 2022 at the very latest.

Nominative Registration

The nominative entries must be completed by entering the composition of the delegation by 23:59 CET (Swiss Time) on Friday, 19 August 2022 at the very latest.

Together with the nominative registration and to accelerate the process of the accreditation, the delegations must send one passport photo of each delegation member to jkoslacz@fig-gymnastics.org.

Requirements for each identity color photo:

- Identity: country_code_event_level_function_full name, for example: CHN_WCH PK_Team Manager_LI Haoyang
- File format: .jpg or .jpeg
- Dimensions: min. 175 X 225 pixels, max. 1750 X 2250 pixels (width X height)
- File size: max. 2MB

Accreditations sent without photos will not be handled with priority. You may wait at the accreditation desk upon arrival.

After the drawing of lots, no athlete can be added. No additional athlete may appear on the Nominative Registration and at accreditation.

8. LICENSES

No Athletes will be accepted without a valid FIG License (at the date of the Nominative Registrations).

Please consult the FIG License Rules for additional information in this respect.

9. JUDGES AND JURY OF APPEAL

Judges

Each Judges' Panel consists of:

Speed: 1 Chair of Judges' Panel (CJP), 1 Start Line and 2 Time Judge (ST/T), 4 check-point or line judges (CP/L)

Speed judges are drawn from the list of FIG Parkour judges from the participating federations and FIG nominated judges, with the CJP directing their work. Any open judge positions will be nominated by FIG.

Freestyle: 6 judges (3 per Difficulty and 3 per Execution) will judge, including one Difficulty judge who is also acting as CJP. One reserve judge should be planned.

Difficulty judges are nominated and invited by the FIG. Execution judges are drawn from the participating federations on-site and attend at the expense of their NF.

Judges are requested to arrive in Tokyo one day before the Judges' Instruction at the very latest, and to be available until the last day of the competition.

Jury of Appeal and Supervisory Board

For the composition of the Jury of Appeal, please consult the FIG Technical Regulations.

The Jury of Appeal will be decided in due time and listed in the Work Plan.

10. DRAWING OF LOTS

The athletes drawing of lots will decide the starting order of the qualification competitions. It will take place during the orientation meeting.

Athletes have the possibility to withdraw from an event until the morning of the draw.

11. COMPETITION FORMAT AND PROGRAMME

Competitions consist of Qualifications, Semi-Finals (Speed only) and Finals. The score from Qualification will not be carried forward. All runs, also the Finals, start from 0 points.

Speed

Speed competitions will be organized on two parallel lanes.

Speed Qualifications

The starting order for the first run of Qualification will be determined by a draw. An intermediate ranking list is established at the end of the first run.

The athletes may choose to have a second run. Should they choose a second run, they have to announce it immediately after the end of their run by raising their hand after seeing their time. The starting order for this second (optional) run is determined by the original starting order, but only with the athletes performing a second run.

For the athletes who have chosen to have a second run, the result of the second run only counts.

The final ranking list of the Qualification will be established at the end of the second run. In case of a tie at any place, the tie-breaking rules set out in art. 4.1 apply.

Runners' lanes- Lane 1 is farthest from the judge's tower and Lane 2 is closest, assigned by draw

Speed Semi-Finals (max. 3 per NF)

Knock-out competition format

The top athletes from the final ranking list of the Qualification (max. 2 per NF) participate in the Semi-Finals. No second run is possible.

In case of a tie at any place, the tie-breaking rules set out in art. 4.1 applies

The highest ranked athlete faces the lowest ranked athlete, and the loser of that race is excluded from advancing to the final. Another example, the athlete ranked 2nd faces the 2nd to last athlete from the Qualification and so on for each athlete to be matched against the appropriate competitor. The loser of each race is excluded from advancing to the final.

In case of a tie at the 6th rank for the Final, the tie-breaking rules set out in art. 4.1– apply.

Three reserve athletes will be able to warm-up for the Semi-Final and Final rounds.

Runners' lanes- Lane 1 is farthest from the judge's tower and Lane 2 is closest, determined by qualifying time

Speed Finals (max. 2 per NF)

The top 6 athletes from the final ranking list of the Qualification or the semi-finals (max. 2 per NF) participate in the Final.

In the final round, the 5th and 6th, the 3rd and 4th and the 1st and 2nd run by pairs. The final ranking is based on the time (no knock out).

In case of a tie at any place, the tie-breaking rules set out in art. 4.1 apply.

The Final is held in one single run.

Runners' lanes- Lane 1 is farthest from the judges' tower and Lane 2 is closest, determined by qualifying time

Freestyle

Freestyle Qualifications

The starting order for the first run of Qualification will be determined by a draw.

The runs of 30 to 70 seconds, are judged based on the criteria defined in the Code of Points.

An intermediate ranking list is established at the end of the first run.

The athletes may choose to have a second run. Should they choose a second run, they have to announce it immediately after the end of their course (before the score is shown) by raising their hand. The starting order for this second (optional) run is determined by the original starting order, but only with athletes performing a second run.

For the athletes who have chosen to have a second run, the result of the second run only counts.

The final ranking list of the Qualification will be established at the end of the second run.

In case of a tie at any place, the tie-breaking rules set out in art. 4.2 apply.

Freestyle Finals (max. 2 per NF)

The top eight athletes from the final ranking list of the Qualification participate in the Final.

In case of a tie at any place, the tie-breaking rules set out in art. 4.2 apply.

The Final is held in one single run.

The starting order is established based on the ranking after Qualification with the best athletes starting last.

15. PUBLICITY

As the Code of Points foresees deductions should the FIG Rules for Advertising and Publicity on attire and equipment not be respected, each federation may fill-in the online FIG Publicity form (FIG Rules for Advertising and Publicity Appendix E for men and F for women) if deemed necessary by 31 August 2022, at the very latest in order to have it approved.

While the Publicity Rule Chart is available on the FIG website under "Rules - Publicity" for additional information, you may also contact tv@fig-gymnastics.org for further assistance if required.

16. VISA

Under the current COVID-19 situation, all participants are required to obtain a visa to travel to Japan, regardless of their nationalities. The LOC will be happy to assist each Delegation member with an official invitation letter, provided that the Visa request is made to the LOC before 10 August 2022. This request must include the following:

- clear copy of the valid passport for each applicant (picture page with specific information) with identity, full name, gender, date of birth, citizenship, passport number, and passport expiry date
- function of the applicant
- flight information including arrival and departure dates of the applicant
- embassy or consulate general office where the applicant applies for his/her own visa

Please note that the visa application support letter will only be sent to the National Federations.

In addition, a certificate for completion of registration to the ERFS (Entrants, Returners Follow-up System) may be required to show at the time of entry to Japan. The registration itself will be done by the LOC for each NF's delegation members. In order for the LOC to complete the registration, clear copy of the valid passport is required to submit before 10 August 2022. The certificate of completion of ERFS registration will be sent to each National Federation by the LOC.

Due to the current situation related to the COVID-19 pandemic, the LOC may ask NF to submit other information or documents apart from the above mentioned. More information will be given closer to the event. While the LOC will be checking with the Ministry of Foreign Affairs regarding the issuance of visas, basic information can be obtained as follows: https://www.mofa.go.jp/j_info/visit/visa/index.html

17. TRANSPORTATION

International Transportation

The international travel to Japan will be at each delegation's own expenses. Due to the COVID-19 infection prevention, Haneda Airport (HND) or Narita Airport (NRT) are currently the only two official airports. The LOC recommends using Haneda Airport as it is closer to the hotels. The FIG and the LOC strongly recommend that each Federation take cancellation insurance for their international transportation.

Local Transportation

The Organizing Committee will offer airport transportation between the Haneda or Narita airport and each hotel.

ATTENTION: Following the medical guidelines for the competition under COVID-19 environment and the instructions by the Japanese government, all accredited Delegations **must**

- stay at one of the official hotels
- book their accommodation through the LOC
- submit the travel schedule information for arrivals and departure by 10 August 2022 at the latest.

18. ACCOMMODATION

Official Hotels

The LOC is delighted to provide FIG and official delegations members with the following selection of hotels.

ATTENTION: In order to follow the medical guidelines for the competition under COVID-19 environment and instruction by the Japanese government, booking of the accommodation through LOC is **compulsory** due to the COVID-19 infection prevention. 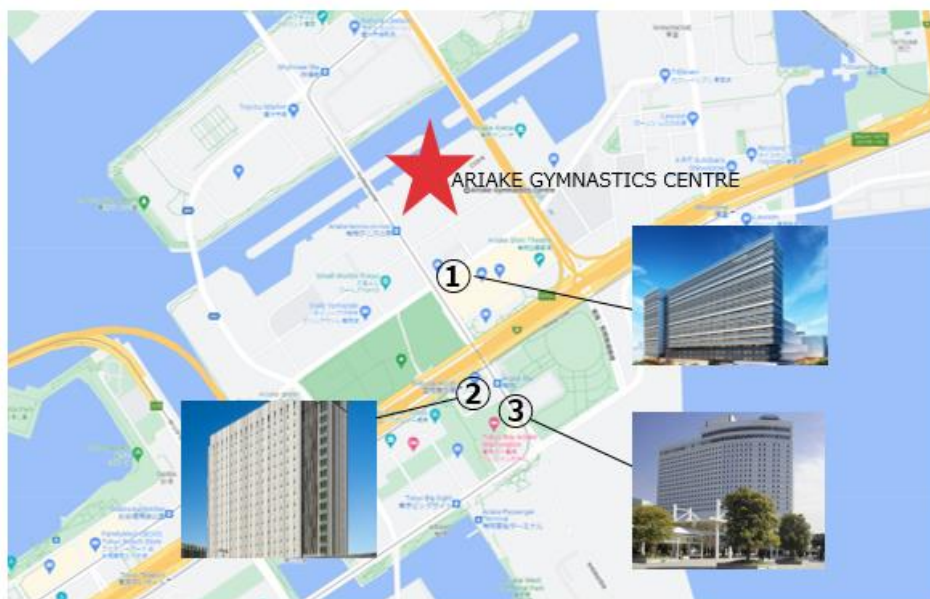

22. INSURANCE

The Host Federation, the LOC and the FIG will not be held responsible for any liabilities in case of accidents, illness (including COVID-19), repatriation and the like.

The FIG TR foresee that all participating Federations are responsible for making their own arrangements to have the necessary valid insurance coverage against illness (including COVID-19), accidents and for repatriation for all the members of their Delegation. Basic insurance (sickness - including COVID-19 - accident and repatriation) in your country of residence is compulsory in order to be able to benefit from coverage by FIG IMSSA subsidiary insurance.

Please also refer to <https://www.gymnastics.sport/site/pages/medical-insurance.php> for additional information regarding the FIG IMSSA insurance for Athletes and Judges.

If the note has not been sent in advance to the LOC (which is strongly recommended), the LOC will verify the Delegation members' insurance upon arrival at the latest (e.g. coverage note or photocopy of the valid policy exclusively in English). Insurance notes in other languages will automatically be refused. The insurance must be valid at least starting from the arrival day of the delegation and must last for the delegations' entire stay.

Delegation members with insufficient insurance coverage must inform the LOC no later than xx August 2022. The LOC will subsequently offer insurance at the Federations' own charge. Further details can be obtained by contacting the LOC.

23. COVID-19 COUNTERMEASURES

ATTENTION: All accredited persons are request to strictly follow the FIG Medical Guidelines and the Medical Guidelines prepared by the LOC.

When more behavioural guidelines based on vaccination are established worldwide, the LOC will introduce the system by following the guidelines. While "FIG Medical Guidelines during COVID-19 Pandemic" are posted on FIG website as follows:

The FIG requires all participants, judges and officials to take standard precautionary measures, such as frequent hand-washing and keeping a physical distance of at least 1.5 meters whenever possible.

According to the current requirement regarding COVID-19, all participants are required to take PCR test within 72 hours arriving Japan.

Those who comes from designated countries or those who are not fully vaccinated (three times) are required 3 days quarantine.

24. WORK PLAN

The Work Plan will be published on the FIG online calendar six weeks at the latest before the start of the competitions.

25. SAFEGUARDING AND PROTECTING PARTICIPANTS IN GYMNASTICS

From the official date of arrival until the official day of departure from the event, participants (athletes, coaches, judges and any other delegation members) have the opportunity to contact by phone or email a Safeguarding Officer in case of harassment or abuse of any type, if they are worried or do not feel comfortable.

There will be one LOC Safeguarding Officer as well as one person from the FIG. The contacts will be communicated upon arrival of the delegations.

26. DOPING CONTROLS

Due to the current situation related to the COVID-19 pandemic, the FIG and the JPN National Federation are constantly in contact and more information will be given closer to the event. Besides the medical guidelines for the particular event, FIG also requires all the participants to follow the standard precautions.

Under the supervision of the FIG, anti-doping control will be organized by the International Testing Agency (ITA) on behalf of FIG and according to the valid WADA Code, Standards and FIG Anti-Doping Rules.

The anti-doping controls may take place at any time.

As per the applicable FIG Therapeutic Use Exemption (TUE) procedure in effect concerning the participation at FIG Events, any athletes in need of a TUE is responsible, together with his/her Federation, to submit his/her request to the FIG no later than 30 days before the start of this competition,

27.ATHLETES' MEETING

The FIG and its Athletes' Representative for Parkour, Ms. Micaela BUONO Pugh, invite athletes from all participating Federations to the Athletes' meeting. All athletes are welcome to attend. The meeting is closed to all other delegation members. Additional information will be included in the Workplan.

An election of the athletes' representative will be held at the end of the athletes' meeting, according to the FIG Statutes and based on candidacies received from the affiliated federations. The athletes' election portion of the meeting will be open to a maximum of two athletes per member federation, with one vote per national federation.

The election will be directed by the President of the Jury of Appeal, accompanied by the President of the PK Commission – Charles Perrière.
