Invitation to the WAG training camp for artistic gymnasts and coaches July 10th to 20th, 2023 in Kuortane (FIN)

Dear Madam, Dear Sir,

The European Gymnastics Technical Committee for Women's Artistic Gymnastics is pleased to invite your Junior gymnasts and their coaches to the 2023 Training Camp in Women's Artistic Gymnastics.

VENUE AND DATES

Kuortane Olympic Training Center

Opistotie 1, 63100 Kuortane, Finland $10^{th} - 20^{th}$ July 2023 (arrival on 10/07/2023, departure on 20/07/2023)

AGE OF THE GYMNASTS

10 to 12 years (born between 2011 and 2013)

There will be no exception regarding the age of the gymnasts.

COMPOSITION OF THE DELEGATIONS

The participation is limited to 2 gymnasts and 2 coaches per National Federation. If a Federation wants to enter additional coaches / gymnasts, they can only be accepted if places are available after the definitive registration date.

NUMERUS CLAUSUS

Because of limited accommodation, only the <u>first 20 National Federations</u> who have submitted their definitive registration and paid the participation fee in full can be **accepted**.

DEFINITIVE REGISTRATION

The definitive registrations (see document attached) must be received at the European Gymnastics office no later than <u>May 15th, 2023.</u>

NOMINATIVE REGISTRATION

The nominative entries (see document attached) must be received by the European Gymnastics office no later than <u>June 12th</u>, <u>2023</u>.



PARTICIPATION FEE

- EURO € 775.- per person. All expenses including accommodation, meals, training facilities, activities and fieldtrip according to the programme are included in this price.
- **EURO € 75. per person.** Arrival and departure transportation from and to the Helsinki airport.

After your participation is confirmed by European Gymnastics, the participation fee will be invoiced by Kuortane Olympic Training Center. The invoices will be sent after definitive registration date **May 15**th, **2023**, but no later than **May 22**nd.

You will receive a payment information form after the European Gymnastics office confirmed your participation.

Please be advised that your definitive registration will only be taken into consideration if the relevant participation fee has been paid by **June 12**th.

SCHEDULE AND PROGRAMME

A detailed schedule will be sent to all participating National Federations at a later date.

RESPONSIBILITY OF THE COACHES

As the gymnasts participating in the Training Camps are minors, it is important to communicate that the coach accompanying the gymnasts at the Training Camp must take care of the welfare and security of their gymnasts at all times.

LECTURES FOR COACHES

Academic and practical lectures for coaches will be organised during the Training Camp. All lectures will be delivered in English.

Coaches from National Federations who do not have a gymnast participating in the Camp have the possibility to take part in the Camp.

The participation fee for these coaches is also 775 €. All expenses including accommodation, meals, training facilities, activities and fieldtrip according to the programme are included in this price. Transportation from and to Helsinki airport is available with extra cost 75 € per person.

ALLERGIES / ILLNESS

National Federations are obliged to advise European Gymnastics of any specific allergies / illnesses etc. pertaining to their gymnasts / coaches.

AIRPORT / TRANSPORT

Helsinki-Vantaa 320 km

Transport from and to Helsinki Airport will be organized for arrival and departure by the LOC. The transport reservations are made while making the definitive registrations.

Transport options (preliminary timetable):

Arrival July 10th

Take off from Helsinki Airport 13:00-14:00 (Flights that arrive before 12.30)

Take off from Helsinki Airport 15:00-16:00 (Flights that arrive before 14:30)

Departure July 20th

Take off from Kuortane OTC 6:00-7:00 (Flights that departure approximately 13:00-14:00)

Take off from Kuortane OTC 9:00-10:00 (Flights that departure approximately 16:00-18:00)

We kindly ask you to notice the transportation schedule while booking the flights. Please send your travel details as soon as possible to the Kuortane Olympic Training Center (see contact details below).

CANCELLATION POLICY

Cancellation without costs is possible until May 22nd.

The reimbursement of the participation fee after payment is only possible on presentation of a medical certificate. Kuortane OTC will charge a processing cost (75 €) before the reimbursement.

DEFINITIVE AND NOMINATIVE APPLICATIONS

- By submitting a provisional and / or definitive and / or nominative application, you accept that data
 you input will be transmitted to and saved by European Gymnastics and Kuortane Olympic Training
 Center.
- Submitted information for the application to an official European Gymnastics Event will be transmitted through the European Gymnastics Office to the official LOC.
- National Federations have access to its data at all times in the case it requires amendment.

DUTY OF THE LOC

The LOC undertakes not to disseminate to its own clients the data submitted by European Gymnastics and National Federations, to use the information exclusively for the event, to respect the retention/erasure period provided and to take any useful measure to safeguard the information in its possession.

DATA PROCESSING

- Data submitted to European Gymnastics and transferred to the LOC may be used for the following purposes:
- Preparation for the organisation of this event
- List of athletes and coaches designated by name
- List of delegations and accompanying persons designated by name

DUTY OF EUROPEAN GYMNASTICS

European Gymnastics shall supply the most recent data to the LOC on time and on a regular basis.

DUTY OF THE LOC

The LOC undertake not to disseminate to its own clients the data submitted by European Gymnastics and National Federations, to use the information exclusively for the event, to respect the retention/erasure period provided and to take any useful measure to safeguard the information in its possession.

RETENTION OF INFORMATION IN ORDER TO PREPARE THE EVENT

- The LOC is entitled to retain for a 6-month period the information related to the entries and the organisation of the event.
- After this deadline, all information received shall be erased except for the accounting data such as invoices. The legal deadline of the host country shall apply.

PUBLICATION OF PHOTOS AND/OR MOVING IMAGES

- By submitting a provisional and / or definitive and / or nominative application through the NF, all participants agree to be filmed, televised, photographed, identified, and otherwise recorded during the event under the conditions and for the purposes now or hereafter authorised by European Gymnastics and LOC in relation with the promotion of the event.
- The National Federation and the participants agree that all photos and moving images taken at the event shall be used solely for personal and non-commercial purposes unless prior written consent is obtained from European Gymnastics.
