SIZE OF The number of units per category and nation in Seniors and Junior for the Qualifications is limited as follows, except for the Organizing Federation. There **DELEGATION** is no limitation on the number of units for the Qualifications for the Organizing Federation. The maximum number of units and officials is as follows: Senior **Officials Junior** Individual Women 6 6 Individual Men 6 6 Mixed Pairs 6 6 6 6 Trios Groups 6 6 Aerobic Dance 6 6 Head of Delegation 1 2 2 Coaches Judaes Minimum 1 **Doctor and Therapists** Every federation must send at least 1 judge with a valid FIG Brevet. The competition consists of Qualifications and Finals in Seniors and Juniors in **EVENT FORMAT** all 6 categories. In case that there are less than 9 participants per category in the Qualifications, no Qualification is necessary. In such cases the LOC will make a decision based on the total number of entries. **QUALIFICATIONS** The participation in Qualifications is limited to the units mentioned in the paragraph "Size of delegation" except for the Organizing Federation. There is no limitation to the number of units for the Organizing Federation. **FINALS** The top 8 (eight) competitors from the Qualifications in Seniors and Juniors in each category (IW, IM, MP, TR, GR, AD) will take part in the Finals (maximum two per Category and Nation). In addition, if the organizing Federation has not qualified competitors in any category in Seniors and in Juniors, it may nominate one participation in max.1 category in each - Senior and Junior of its choice. **PROVISIONAL** 29th of August 2024 (Thursday) – Arrival, accreditation and training early **SCHEDULE** arrivals 30th of August 2024 (Friday) -Trainings, Orientation meeting, Judges meeting and instructions, Qualifications 31st of August 2024 (Saturday) – Qualifications 1st of September 2024 (Sunday) - Finals 2nd of September 2024 (Monday) – Departure There might be some changes in the Provisional Schedule depending on the total number of entries. The Detailed Program will be prepared and distributed to all participating Federations with the Work Plan not later than 19th of August 2024. For early arrivals on 28th of August 2024 the LOC may provide an accommodation in the official Hotels for the same price as during the event. 	The request must be made using the official form and include the function, full name, gender, date of birth, citizenship and passport number, passport expiry date, the arrival and departure dates of the Delegation Member as well as the city where the visa application support letter must be sent to.
INSURANCE	The Host Federation, the LOC and the FIG will not be held responsible for any
	liabilities in case of accidents, illness (including COVID-19), repatriation and the like. The FIG Technical Regulations foresee that all participating Federations are
	responsible for making their own arrangements to have the necessary valid insurance coverage against illness, accidents and repatriation for all the members of their Delegation.
	Basic insurance (sickness, accident and repatriation) in your country of residence is compulsory in order to be able to benefit from coverage by FIG

- ND for the categories IW/ IM/ MP/ TR/ GR will also be held (not sanctioned). For those age groups an exception in the age is possible only for TR and GR categories as follows:
- TR category max one of the gymnasts could be from a lower age group In AG 12-14 (born 2013 2015) and in ND 9-11 (born 2016 2017)
- GR category max two of the gymnasts could be from a lower age group In AG 12-14 (born 2013 2015) and in ND 9-11 (born 2016 2017)

Conditions, number of units, deadlines and prices are the same as for the Seniors and Juniors. No FIG license is requested.

The Draw for the starting order for Qualifications and Finals will be done in advance by the Technical Committee of Aerobic Union Bulgaria based on the Definitive entries and will be distributed to all Nations.

More information will be given with the Work Plan which will be distributed to all registered federations not later than 19th of August 2024.
