## Women's Artistic Gymnastics Training Camp

July 7<sup>th</sup> to 17<sup>th</sup>, 2025 in Kuortane (ITA)

The European Gymnastics Technical Committee for Women's Artistic Gymnastics is pleased to invite your Junior gymnasts and their coaches to the 2025 Training Camp in Women's Artistic Gymnastics.

## **VENUE AND DATES**

<u>Kuortane Olympic Training Center</u> Opistotie 1, 63100 Kuortane, Finland 7<sup>th</sup> – 17<sup>th</sup> July 2025 (**arrival on 07/07/2025**, **departure on 17/07/2025**)

#### AGE OF THE GYMNASTS

10 to 12 years (born between 2013 and 2015) *There will be no exception regarding the age of the gymnasts.* 

## **COMPOSITION OF THE DELEGATIONS**

The participation is limited to 3 gymnasts and 2 coaches per National Federation. If a Federation wants to enter additional coaches / gymnasts, they can only be accepted if places are available after the definitive registration date.

#### **NUMERUS CLAUSUS**

Because of limited accommodation, only the *first 22 National Federations* who have submitted their definitive registration and paid the participation fee in full can be **accepted**.

## **DEFINITIVE REGISTRATION**

The definitive registrations (see document attached) must be sent to European Gymnastics (<u>info@europeangymnastics.com</u>) until <u>April 29<sup>th</sup>, 2025 (included).</u>

## NOMINATIVE REGISTRATION

The nominative registrations (see document attached) must be sent to European Gymnastics (<u>info@europeangymnastics.com</u>) until June 16<sup>th</sup>, 2025 (included).



## **PARTICIPATION FEE**

- **EURO € 800.- per person**. All expenses including accommodation, meals, training facilities, activities and fieldtrip according to the programme are included in this price.
- EURO € 80.- per person. Arrival and departure transportation from and to the Helsinki airport.

After your participation is confirmed by European Gymnastics, the participation fee will be invoiced by Kuortane Olympic Training Center. The invoices will be sent after definitive registration date **April 29<sup>th</sup>**, **2025**, but no later than **May 16<sup>th</sup>**.

You will receive a payment information form after the European Gymnastics office confirmed your participation.

Please be advised that your registration will only be taken into consideration if the relevant participation fee has been paid by **June 16**<sup>th</sup>, **2025**.

Participation fees can be reimbursed only if a medical certificate is provided.

#### SCHEDULE AND PROGRAMME

A detailed schedule will be sent to all participating National Federations at a later date.

### **RESPONSIBILITY OF THE COACHES**

As the gymnasts participating in the Training Camps are minors, it is important to communicate that the coach accompanying the gymnasts at the Training Camp must always take care of the welfare and security of their gymnasts.

#### LECTURES FOR COACHES

Academic and practical lectures for coaches will be organised during the Training Camp. All lectures will be delivered in English.

Coaches from National Federations who do not have a gymnast participating in the Camp have the possibility to take part in the Camp.

The participation fee for coaches without gymnast is also 800 € per person.

This fee includes accommodation, meals, training facilities, activities and fieldtrip according to the programme. Transportation from and to Helsinki airport costs additional 80 € per person.

#### **ALLERGIES / ILLNESS**

National Federations are obliged to advise European Gymnastics of any specific allergies / illnesses etc. pertaining to their gymnasts / coaches.

#### ACCIDENT AND HEALTH INSURANCE

Health and accident insurance is recommended to all participants. In case of illness or accident, the European Gymnastics IMSSA insurance may be used by officially registered participants.

## **AIRPORT / TRANSPORT**

Helsinki-Vantaa 320 km Transport from and to Helsinki Airport will be organised for arrival and departure by the LOC. The transport reservations are made while making the definitive registrations.

Departure from Helsinki Airport 14:00-15:00 (Flights that arrive before 13:30)

Departure from Helsinki Airport 18:00-19:00 (Flights that arrive before 17:30)

Departure from Kuortane OTC 6:00-7:00 (Flights with departure approximately 13:00-15:00)

Departure from Kuortane OTC 08:30-09:30 (Flights with departure after 15:00)

We kindly ask you to notice the transportation schedule while booking the flights. Please fill out your travel details information form you will receive from European Gymnastics once your registration is confirmed.

We kindly ask each delegation to prepare a small show that represents something specific about their country (please bring special items, music or anything else you can think of).

## **CANCELLATION POLICY**

Cancellation without costs is possible until May 15<sup>th</sup>, 2025.

The reimbursement of the participation fee after payment is only possible on presentation of a medical certificate. Kuortane OTC will charge a processing cost (75 €) before the reimbursement.

For participants under the age of 18, it is the responsibility of your national gymnastics federation that the agreement is equally obtained from the parents.

#### DEFINITIVE AND NOMINATIVE APPLICATIONS

- By submitting a provisional and / or definitive and / or nominative application, you accept that data you input will be transmitted to and saved by European Gymnastics and the local organisers.
- Submitted information for the application to an official European Gymnastics Event will be transmitted through the European Gymnastics Office to the official LOC.
- National Federations have access to its data at all times in the case it requires amendment.

#### **DUTY OF THE LOC**

The LOC undertakes not to disseminate to its own clients the data submitted by European Gymnastics and National Federations, to use the information exclusively for the event, to respect the retention/erasure period provided and to take any useful measure to safeguard the information in its possession.

#### **DATA PROCESSING**

- Data submitted to European Gymnastics and transferred to the LOC may be used for the following purposes:
- Preparation for the organisation of this event
- List of athletes and coaches designated by name
- List of delegations and accompanying persons designated by name

#### **DUTY OF EUROPEAN GYMNASTICS**

European Gymnastics shall supply the most recent data to the LOC on time and on a regular basis.

#### **DUTY OF THE LOC**

The LOC undertake not to disseminate to its own clients the data submitted by European Gymnastics and National Federations, to use the information exclusively for the event, to respect the retention/erasure period provided and to take any useful measure to safeguard the information in its possession.

#### **RETENTION OF INFORMATION IN ORDER TO PREPARE THE EVENT**

- The LOC is entitled to retain for a 6-month period the information related to the entries and the organisation of the event.
- After this deadline, all information received shall be erased except for the accounting data such as invoices. The legal deadline of the host country shall apply.

#### **PUBLICATION OF PHOTOS AND/OR MOVING IMAGES**

- By submitting a provisional and / or definitive and / or nominative application through the NF, all participants agree to be filmed, televised, photographed, identified, and otherwise recorded during the event under the conditions and for the purposes now or hereafter authorised by European Gymnastics and LOC in relation with the promotion of the event.
- The National Federation and the participants agree that all photos and moving images taken at the event shall be used solely for personal and non-commercial purposes unless prior written consent is obtained from European Gymnastics.
