INVITATION AEROBIC GYMNASTICS TRAINING CAMP & COACHES COURSE July 5th to 11th, 2025 in Loutraki (GRE)

Dear gymnastics friends,

The European Gymnastics Technical Committee for Aerobic Gymnastics (TC-AER), in collaboration with the Hellenic Gymnastic Federation (LOC), invites interested coaches and athletes from the European Gymnastics member federations to participate in their 2025 AER Training Camp and Coaches Course.

INTRODUCTION

The philosophy of the camp is to provide access and enjoyment for those who would like to improve their performance under supervising coaching experts provided by the TC-AER. The experts will organise the trainings for young participating gymnasts and their coaches. They will also allow the exchange of experience and plan lectures for the coaches. The participants will learn, among other things, how to plan the trainings and the progressive construction of routines.

PARTICIPANTS

No limitation of the number of participants per National Federation. However, the maximum number of gymnasts is **limited to 120 gymnasts**. Registrations will be accepted according to the principle **'first come, first served'**.

The course will be organised in several workgroups.

AGE OF THE ATHLETES

Only gymnasts aged 11 to 17 years can participate (born between 2008 and 2014).

ACCIDENT AND HEALTH INSURANCE

Health and accident insurance is recommended to all participants. In case of illness or accident the European Gymnastics IMSSA insurance may be used by officially entered participants, nevertheless cash payment may be requested by medical professionals and hospitals.





RESPONSIBILITY OF THE COACHES

As gymnasts participating in the training camp are minors, it is important to underline that the coach(es) accompanying the gymnasts must take care of the welfare and security of their gymnasts.

Extra leisure activities will be proposed at the special price (to be arranged on arrival).

The camp will include an introduction on 'how to best prepare your gymnasts for competitions' including:

- Periodisation Training
- Conditioning Circuit
- Various Skills, Jumps, Strength
- Safe progressive practice in training
- Theory and practice in spotting and safety
- Code of Points (introduction and explanation)
- Choreography
- Dance styles
- Ballet
- Acrobatic elements
- Collaborations and partnerships

The Coaches Course will include practical training sessions as well as theoretical lessons. The course is designed to assist coaches in developing their skills in preparing gymnasts for top performances. <u>All coaches are welcome to attend the Coaches Course, regardless of whether they have registered gymnasts or not.</u>

Submitted information for the application to an official European Gymnastics event will be transmitted through the European Gymnastics office to the official LOC. NF always has access to its data in order to amend it.

DUTY OF THE LOC

The LOC undertakes not to disseminate to its own clients the data submitted by European Gymnastics and NFs, to use the information exclusively for the event, to respect the retention/erasure period provided and to take any useful measure to safeguard the information in its possession.

DATA PROCESSING

Data submitted to European Gymnastics and transferred to the LOC may be used for the following purposes:

- Preparation of the organisation of this event
- List of athletes and coaches designated by name
- List of delegations and accompanying persons designated by name

DUTY OF EUROPEAN GYMNASTICS

European Gymnastics shall supply the most recent data to their LOC on time and on a regular basis.

RETENTION OF INFORMATION IN ORDER TO PREPARE THE EVENT

The LOC is entitled to retain for a 6-month period the information related to the entries and the organisation of the event.

After this deadline, all information received shall be erased except for the accounting data such as invoicing. The legal deadline of the host country shall apply.

PHOTOS AND VIDEOS

By submitting a provisional and/or definitive and/or nominative registration through the NF, all participants agree to be filmed, photographed, identified and otherwise recorded during the event. Photos and videos taken at the event shall be used solely for personal and non-commercial purposes unless prior written consent is obtained from European Gymnastics.
