AGE LIMITS	Youth: as per the FIG Technical Regulations Juniors: as per the FIG Technical Regulations Seniors: as per the FIG Technical Regulations											
JUDGES & JURIES	The number of Juries (judges' panels) may be decided by the Organizing Member Federation depending on the number of participating competitors and judges. All judges must have a current valid FIG brevet in the discipline concerned. The Juries are set up by a draw and directed by the Technical Delegate from the judges present at the event. Priority will be given to the judges of the highest category. If, on the day of the competition, there are no sufficient numbers of judges in the requested categories, the Technical Delegate may take whatever action needed to secure the running of the event. Each participating federation must provide minimum one judge Cat. 1, 2, 3 or 4 with current valid brevet. Failure to do so, will result in a fine of CHF 2'000.- to be paid to the LOC until the Definitive Registration date (15-01-2024).											
REGISTRATION DEADLINES	Provisional, Definitive and Nominative Registrations must be completed by sending the composition of the delegation to the LOC. ENTRY FEES	The costs for the entry fees are: IW/IM: 45€ - MP: 70€ - TRIO:80€ - GROUP: 90€ - Aerodance Group: 100€ The invited participating federations must pay for all entry fees. At the time of the Definitive entry (2 months prior to the event) 100% of the entry fee must be paid to the LOC. All the entry fees are not refundable.											
EVENT FORMAT	The Aerobic Gymnastics International Open Competition will have Qualifications, and Finals in all categories. Aerobic Gymnastics Categories: IW, IM, MP, TR, GR, AD. Qualifications: participation is not limited by nation / category / youth. The participation in the semi-finals is limited to 3 units per country in each category The participation in the finals is limited to 2 units per country in each category.											
ACCREDITATION	In addition, the LOC will distribute information regarding the gymnasts' safeguarding plan. The accreditation will take place at the Sports Hall "Os Marialvas" upon arrival to Cantanhede. The accreditations will only be handed out to the Head of Delegation. All delegations must deliver 2 memory sticks with the musics of all routines, national anthem and flag, SPORTIVE INSURANCE declaration , passports of all members and FIG Licenses. In addition, the LOC will distribute information regarding the gymnasts' safeguarding plan.											

PROVISIONAL SCHEDULE	- Day 1, 23rd March: Arrival of Delegations/Training Sessions (Depending of the number of participants) - Day 2, 24th March: Training Sessions (Depending of the number of participants) - Day 3, 25th March: (Depending of the number of participants) - Qualifications - Orientation meeting, judges meeting (IOC & Youth Competition) - Day 4, 26th March: Qualifications - Day 5, 27th March: Qualifications - Day 6, 28th March: Finals - Day 7, 29th March: Finals - Day 8, 30th March: Departure of Delegations (All day)
PARTICIPATION	The International Open Competition consists of qualifications and finals. There will be qualifications only for the categories and age groups with more than 9 participants. In case of a tie in any place, the tie-breaking rules are as set by FIG. The categories with more than 40 units will have a semi-final. Will be qualified for the semi-final the top 24 units (maximum of 3 per country). Participation in the finals: The top eight units per category and age group will qualify for the Finals. In case of a tie at any place, the tie-breaking rules are the FIG World Championships Rules. The LOC may cancel the competition in the respective category if at the time of the definitive entry, there are less than 3 countries registered in a category. In case of such a cancelation, the LOC must reimburse, in full, the entry fee and payments made for accommodation. Should flights have to be cancelled due to the above, the risk is at the charge of the participating member Federations.
SIZE OF THE DELEGATION AND FIG LICENSE	The number of participants by nation, category and age group is not limited. All Youth, Juniors and Seniors gymnasts in good standing with the correct age and holding a valid FIG license until the end of the event, may participate. The LOC will be responsible for checking the validity of all gymnasts Licenses. No gymnasts will be accepted without a valid FIG License until the end of the event.
CATEGORIES	IW / IM / Mix Pair / Trio / Group / Aerodance (all age categories).
DRAWING OF LOTS	The drawing of lots will take place at the Gymnastics Federation of Portugal Federation two weeks after the closing date of the nominative registration. After publication of the draw to all participating federations there will be an opportunity to modify the position of the gymnasts' starting order within 3 days by using the official document.
MEDICAL SERVICES	The Local Organizing Committee will provide first aid medical services. A physiotherapist will be present during the competitions as well members of the Portuguese Red Cross specialized in first aids. Medical support is also available at 5 min. distance.
VISA	Please verify immediately with your travel agent or the Portuguese Embassy or Consulate in your country if a visa is required for your travel to Portugal. The LOC will be happy to assist each Delegation member with an official invitation letter, provided that the request is made before 21, January, 2026 to the LOC. To request an invitation letter, please send the following information to the LOC: Full Name, Gender, Date of Birth, Citizenship, Passport Number, Passport Expiry Date, Function/Role within the Delegation, Arrival and Departure Dates, City where the visa application support letter should be sent. Please ensure that all information is complete and accurate to avoid delays in visa processing.
INSURANCE	The Host Federation, the LOC and the FIG will not be held responsible for any liabilities in the event of accidents, illness (including COVID-19), repatriation, or similar occurrences.

	In accordance with the FIG Technical Regulations, all participating Federations are responsible for ensuring that all Delegation Members have valid insurance coverage for illness, accidents, and repatriation during the entire duration of their stay. It is mandatory that Delegation Members are covered by basic insurance (covering sickness, accident, and repatriation) in their country of residence, in order to benefit from coverage by the FIG IMSSA subsidiary insurance. Each Delegation must present either a cover note or a photocopy of the valid insurance policy. The policy must be valid starting from the day of arrival and must remain valid for the entire duration of the stay. If a Federation cannot provide proof of valid insurance, the LOC will offer insurance coverage at the Federation's own expense, at a cost of: 50 EUR per person/day.
SAFEGUARDING	From the official day of arrival until the official day of departure, all participants — including gymnasts, coaches, judges, and other Delegation Members — will have the possibility to contact the LOC Safeguarding Officer by phone or email in case of: • Harassment • Abuse of any kind • Any situation where they feel uncomfortable or unsafe The contact information for the LOC Safeguarding Officer will be provided to all Delegations upon arrival on site. As part of the FIG's commitment to athlete welfare and youth protection, posters of the "10 Golden Rules of Gymnastics", part of the FIG's awareness campaign, must be clearly displayed in several key areas, including: • Training Halls • Warm-Up Areas • Public Zones These measures are in place to ensure a safe, respectful, and supportive environment for all participants throughout the event.
INTERNATIONAL TRANSPORTATION	The invited participating federations must pay for the travel costs of their delegation members. The Travel Schedule Form must be returned to the LOC by 21, January, 2026.
LOCAL TRANSPORTATION	It is mandatory for all delegations to book their local transportation through the LOC. The Organizers will arrange at a determined fee, the transport service from the LISBON International airport and OPORTO International airport to the accommodation place in Cantanhede and to the competition hall The costs are per person. Transportation from Oporto Airport to the competition venue or hotel and back – 80€ (eighty Euros). Transportation from Lisbon Airport to the competition venue or hotel and back – 100€ (hundred Euros). The LOC only ensure the Local Transportation between the hotels and the hall of the competition to the participants who booked the accommodation by the LOC. The invited participating federations must pay for the transportation expenses of their delegation members until 21, January, 2026.
ACCOMMODATION	It is mandatory for all delegations to book their accommodation through the LOC.
