Dear National Federations, dear gymnastics friends

We are pleased to invite your junior MAG gymnasts as well as their coaches to participate in the **2026 Training Camp for gymnasts and coaches.**

DATES AND LOCATION

Arrival on 29/06/2026, Departure on 08/07/2026
Salerno, Italy

AGE OF THE GYMNASTS

13 to 16 years (born between 2010 and 2013)

There will be no exceptions regarding the age of the gymnasts.

COMPOSITION OF THE DELEGATIONS

The participation is limited to maximum **2 gymnasts and 2 coaches** for each federation.

If a federation wants to enter additional coaches/gymnasts, they can only be accepted if places are available after the deadline for registrations.

NUMERUS CLAUSUS

Because of limited accommodation, **only the first 13 federations** having sent their registration and having paid the participation fee can be accepted.

NOMINATIVE REGISTRATIONS

The nominative registrations must be submitted to European Gymnastics using the Registration Form below. **Deadline: April 15th, 2026.**

PARTICIPATION FEE

EURO 850.- per person.

The participation fee includes:

- Accommodation in double room with meals at hotels and affiliated structures.
- Access to and use of sports facilities (gym, swimming pool, beach).
- Transportation service for all travel within the city of Salerno.
- A programme of recreational and cultural activities.
- Welcome kit (T-shirt, water bottle, cap, etc.).

PAYMENT

European Gymnastics will send an invoice once your registration is received.

Please note that your registration will only be taken into consideration if the participation fee has been paid within the deadline.

The reimbursement of the participation fee is only possible on presentation of a medical certificate.

CANCELLATION POLICY

As accommodation is in very high demand in Salerno during Summer, cancellation is not possible. Replacements within delegations is of course allowed.

SCHEDULE AND PROGRAMME

RESPONSIBILITY OF THE COACHES

As the gymnasts participating in the training camps are still minor, the coach accompanying the gymnasts is responsible for taking care of their welfare and security.

LECTURES FOR COACHES

Academic and practical lectures for coaches will be organised during the training camp. The language used will be English. Coaches can take part in those courses and lectures even if they don't have gymnasts participating in the training camp.

The participation fee for these coaches is **EURO 850.-** (including accommodation, meals, sports and leisure facilities, local transport in Salerno, welcome kit).

ALLERGIES / MEDICAL CONDITIONS

National Federations are obliged to advise European Gymnastics of any specific allergies / illnesses etc. pertaining to their gymnasts / coaches.



By submitting a registration, the participants of your national gymnastics federation agree to the processing of personal data contained for logistical purposes related to this European Gymnastics event and the publication of photos and/or videos for educational or communication purposes. For participants under the age of 18, it is the responsibility of your national gymnastics federation that the agreement is equally obtained from the parents.

DEFINITIVE AND NOMINATIVE REGISTRATIONS

By submitting a provisional and/or definitive and/or nominative registration, you accept that data you input will be transmitted to and saved by European Gymnastics. Submitted information for the application to an official European Gymnastics event will be transmitted through the European Gymnastics office to the official LOC. NF has access to its data at all times in order to amend it.

DATA PROCESSING

Data submitted to European Gymnastics and transferred to the LOC may be used for the following purposes:

- Preparation of the organisation of this event
- List of athletes and coaches designated by name
- List of delegations and accompanying persons designated by name

DUTY OF EUROPEAN GYMNASTICS

European Gymnastics shall supply the most recent data to their LOC on time and on a regular basis.

DUTY OF THE LOC

The LOC undertake not to disseminate to its own clients the data submitted by European Gymnastics and NFs, to use the information exclusively for the event, to respect the retention/erasure period provided and to take any useful measure to safeguard the information in its possession.

RETENTION OF INFORMATION IN ORDER TO PREPARE THE EVENT

The LOC is entitled to retain for a 6-month period the information related to the entries and the organisation of the event.

After this deadline, all information received shall be erased except for the accounting data such as invoicing. The legal deadline of the host country shall apply.

PHOTOS AND/OR VIDEOS

By submitting a provisional and/or definitive and/or nominative registration through the NF, all participants agree to be filmed, photographed, identified and otherwise recorded during the event. Photos and videos taken at the event shall be used solely for personal and non-commercial purposes unless prior written consent is obtained from European Gymnastics.
